These conditions can stipulate where the offender should live, whom they may or may not see, and compulsory attendance on programmes such as anger management. If an offender breaks these conditions they can be sent back to prison.

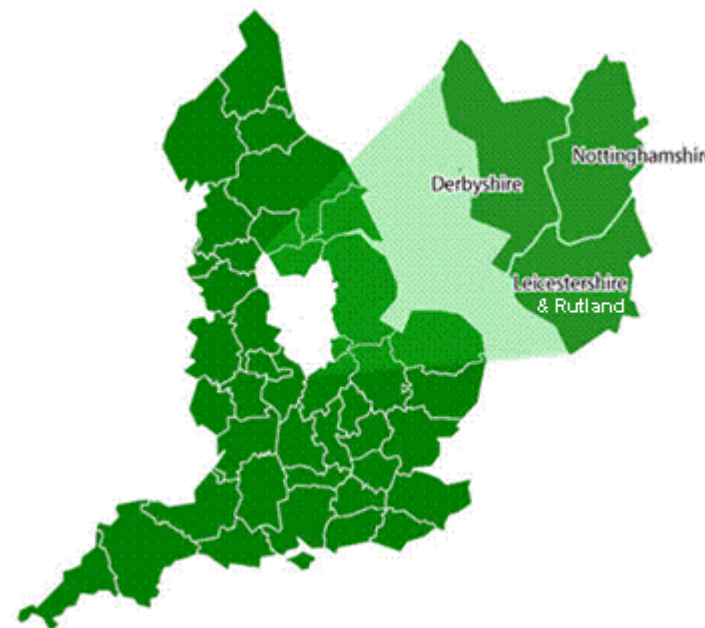

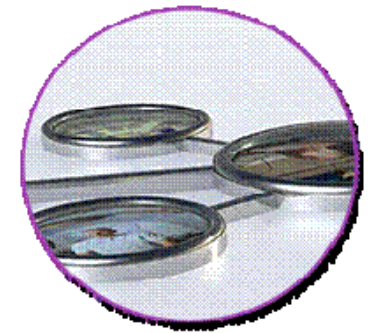
**Reducing Re-offending**

## Who we are

We are part of the Criminal Justice System, working with the police, Courts, Local Authorities, prisons and the National Probation Service. We employ almost 870 staff and supervise around 6,800 offenders at any one time, who have been assessed as being low and medium risk of harm cases. These include offenders on community orders, in prison, or released on licence to serve the remainder of their sentence in the community.

The CRC serves the four counties of Derbyshire, Leicestershire, Nottinghamshire and Rutland.

## What we do

Our role is to manage the majority of offenders under probation supervision. We work alongside the National Probation Service, which manages offenders who have been assessed as presenting high risk of harm to others. We are a key partner in Integrated Offender Management – which brings together local agencies to target offenders causing the most concern to communities. Our skilled and experienced staff work with offenders to turn their lives around and protect the public. We have particular expertise in working with gang members and women offenders.

We also deliver Restorative Justice which gives victims the chance to tell offenders of the real impact the crime has had on their lives, to get answers to their questions and an apology.

## Community Payback

Many of the offenders we supervise are sentenced to compulsory unpaid work. Known as Community Payback, this work is designed to be tough, demanding and to enable offenders to make amends to local communities.

The scheme gives local people a say in what unpaid work takes place in their area. From bringing derelict areas and buildings back into public use, to cleaning graffiti from the streets, offenders on compulsory unpaid work orders deliver improvements that might not otherwise happen.

More than 267,000 hours of unpaid work have been completed that has directly benefited communities in the CRC area.

## Community sentences

We manage community sentences for adult offenders imposed by the Courts. The offenders we supervise can be required to attend treatment for drug or alcohol misuse or for mental health. They may be ordered to live in a specific place. They may also be expected to improve their literacy and numeracy skills to increase their chances of finding employment. Other elements of the community sentence can include prohibited activities, and curfews supported by electronic tagging. We also run programmes to tackle the root causes of offending. They teach offenders to think before they act, assess and resolve issues, and address specific problems with behaviour such as anger management.

Offenders who don't comply with what's required of them can be returned to Court or recalled to prison.
